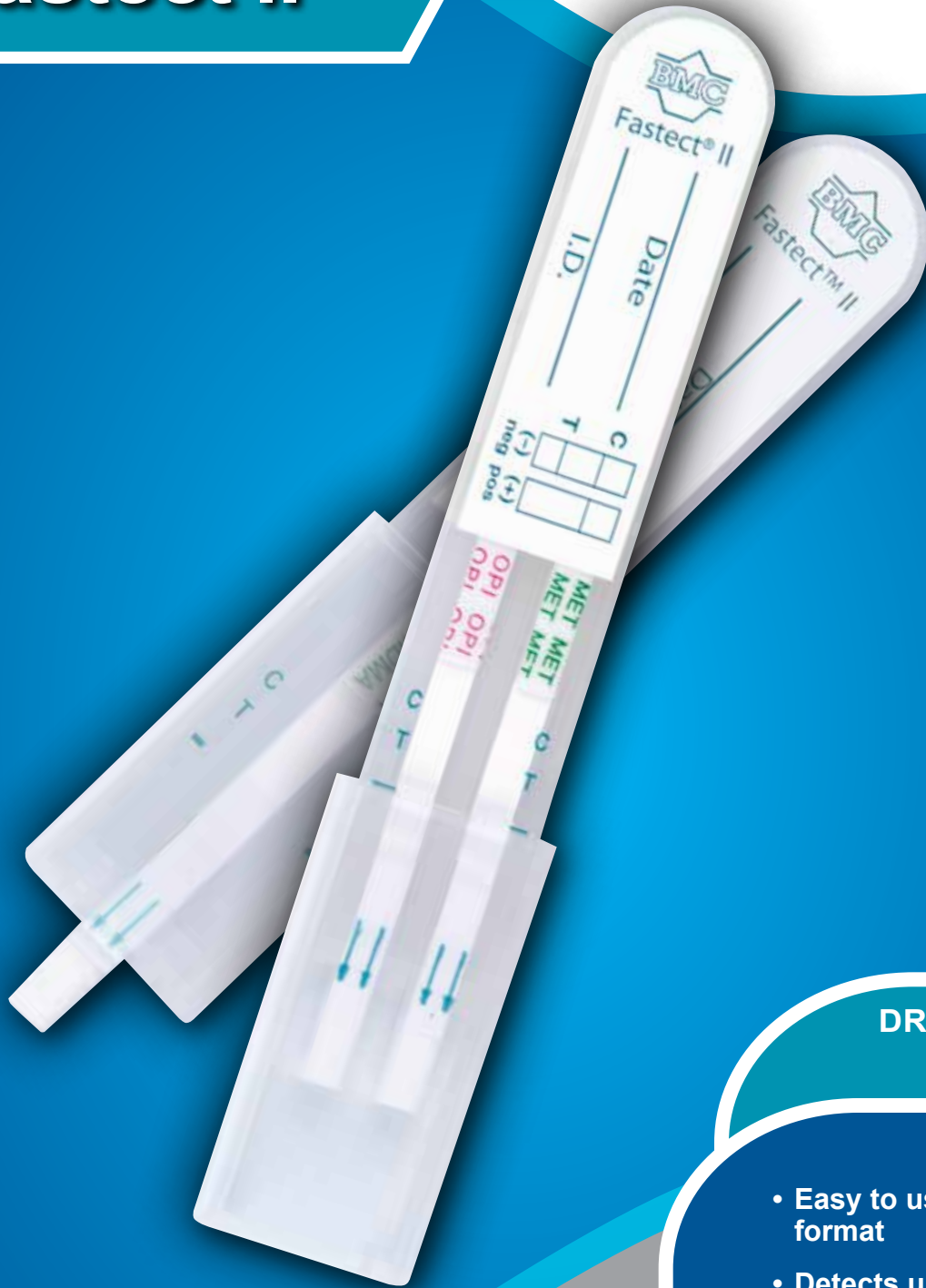

Easy to use Dipstick Format

Dipstick drug test kits are the simplest of all kits to use. Simply dip the tip of the test into the urine specimen for ten seconds and read the test result in five minutes. The Fastect II dipstick test is one of the easiest ways to perform drug testing. The simplicity of the Fastect II dipstick design makes these some of the most economical tests as well.

Detects Up to Four Drugs of Abuse

The Fastect II can test for up to four drugs with one test. The Fastect II is also available in configurations that can test for one, two, and three drugs. This allows customers to choose the only number of panels required to detect the specific drugs their clients are likely to abuse. Limiting the number of panels is the most certain way to lower drug testing costs.

Minimizes Exposure to Urine

The Fastect II design incorporates a sliding cap that minimizes operator exposure to urine. The operator slides the cap up to expose the test strips to perform the test. After wetting the strips in the urine specimen the operator slides the cap to the down position, effectively covering the wetted strips while the test results develop.

CLIA Waived

The Fastect II has CLIA waived status. This means that Fastect II test results obtained by persons with no laboratory experience and who have only read the testing instructions are comparable to results obtained by trained laboratory technicians. CLIA-waived status allows the Fastect II to be used in a wide variety of settings and reduces the burden otherwise required by CLIA regulations.

Step 1
Slide protective cover up to expose tips.



Step 2
Dip the tips into specimen.



Step 3
Slide cover down to cover tips, and read test result.
